Each customer may receive up to \$15 in available rebates, as set forth in these terms. Products must be purchased and installed at the participating TECH-NET Professional Auto Service Center®.

Qualifying Products and Rebate Amounts - CARQUEST® Brand Red and/or premium Blue Oil and Air filters qualify for a \$5 rebate per filter – limit one (1) oil filter and one (1) air filter per customer for rebate purposes. A \$5 Service Certificate (redeemable at the original TECH-NET service center toward a future filter change service) and up to \$10 Rebate Check by mail-in rebate will be provided after purchase and installation of qualifying CARQUEST Filtration products installed by a participating TECH-NET PROFESSIONAL AUTO SERVICE center. **Total possible rebate amount: \$15.**
